TOOLS REQUIRED

Safety equipment (i.e. gloves, goggles, and clothing), 9/16" Open End Wrench.

INSTALLATION OF NEW BLEED VALVE


1. Apply PTFE tape or sealant on male pipe threads. Install Bleed Valve taking caution not to over tighten. Install so that the 1/8" Bleed Hole is facing away from all personnel when the valve is opened.

REMOVAL OF BLEED VALVE FROM SERVICE

- 1. Safety equipment must be worn before continuing with the next step.
- 2. Before removing the Bleed Valve, ensure that the system is purged of all product.

OPERATION WARNING

When operating a Bleed Valve, you must wear safety gloves, goggles, and clothing. Open and close the Bleed Valves by hand only. Do not use pliers or wrenches. When opening, do not force the stem past the body crimp.
